Description of this Fund


The Trans-Tasman Fund is a select portfolio of approximately 25-35 well researched companies which are primarily New Zealand and Australian listed companies. The Trans-Tasman Fund is actively managed, which means the holdings and returns may differ considerably from its benchmark. While the Trans-Tasman Fund tends to be fully invested in shares, when there are few compelling investment opportunities the Fund may hold some cash or

What are the Risks of Investing?

The risk indicator for the Devon Trans-Tasman Fund is below:



How has the Fund performed in the past?

Annual Return Graph²



Devon took over the portfolio management of the Fund from a previous manager in March 2010. This shows the return after fund charges and tax for each year ending 31 March since the Fund started with Devon. The last bar shows the average annual return since the Fund started, up to 31 December 2017. **Important:** This does not tell you how the Fund will perform in the future. Returns in this update are after tax at the highest prescribed investor rate (PIR) of tax for an individual New Zealand resident. Your tax may be lower.

What fees are investors charged?³

Investors in the Trans-Tasman Fund are charged Fund charges. In the year to 31 December 2017 these were:


Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the Devon Trans-Tasman Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$1411 (that is 14.11% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$1366 for the year.

What does the Fund invest in?
