What is the purpose of this update?

This document provides key information about the Devon Alpha Fund ("Alpha Fund"). It tells you how the Fund has performed and what fees it charged, and will help you to compare it with other funds. Description of this Fund

The Alpha Fund is a concentrated portfolio of approximately 10-15 select companies on the New Zealand and Australian share markets. The Alpha Fund does not follow an equity index and is actively managed. When appropriate investment opportunities cannot be identified, the Alpha Fund may hold cash or cash equivalent securities. The Alpha Fund aims to generate capital growth over the long term.

What are the Risks of Investing?

The risk indicator for the Devon Alpha Fund is below:

Investors in the Alpha Fund are charged Fund charges. In the year to 30 September 2017 these were:

Example of how this applies to an investor

Chris had \$10,000 in the Devon Alpha Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$194 (that is 1.94% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$156 for the year.
