What is the purpose of this update?

This document provides key information about the Devon Trans-Tasman Fund ("Trans-Tasman Fund"). It tells you how the Fund has performed and what fees it charged, and will help you to compare it with other funds. Devon Funds Management Limited prepared this statement in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this Fund

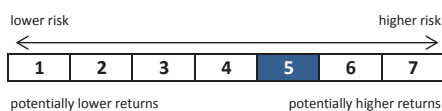
The Trans-Tasman Fund is a select portfolio of approximately 25-35 well researched companies which are primarily New Zealand and Australian listed companies. The Trans-Tasman Fund is actively managed, which means the holdings and returns may differ considerably from its benchmark. While the Trans-Tasman Fund tends to be fully invested in shares, when there are few compelling investment opportunities the Fund may hold some cash or cash equivalent securities.

What are the Risks of Investing?

The risk indicator for the Devon Trans-Tasman Fund is below:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way. This risk indicator is not a guarantee of a fund's future performance. 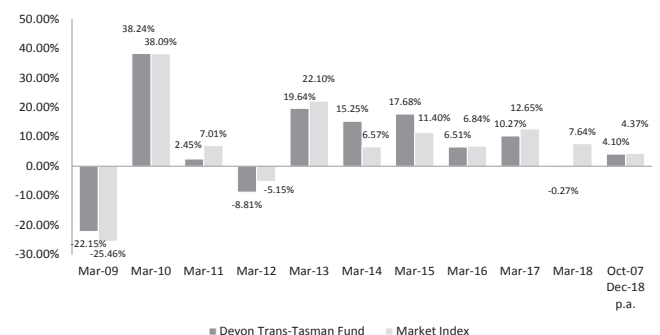

How has the Fund performed in the past?

Annual Return Graph²



This shows the return after fund charges and tax for each year ending 31 March since the Fund started. What fees are investors charged?³

Investors in the Trans-Tasman Fund are charged Fund charges. In the year to 31 March 2018 these were:

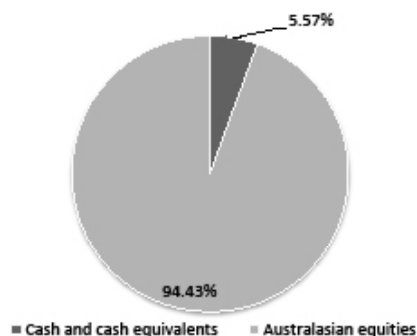
Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the Devon Trans-Tasman Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of -\$207 (that is -2.07% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of -\$288 for the year.

What does the Fund invest in?
