

# Fund update for the quarter ended 30 September 2018

This Fund update was first made publicly available on 26 October 2018.



### What is the purpose of this update?

This document provides key information about the Devon Australian Fund ("Australian Fund"). It tells you how the Fund has performed and what fees it charged, and will help you to compare it with other funds. Devon Funds Management Limited prepared this statement in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this Fund


The Australian Fund is a select portfolio of approximately 25-35 companies which are primarily Australian listed companies. The Australian market offers exposure to a number of sectors that are not available in New Zealand. The Australian Fund is actively managed, which means the holdings and investment returns may differ considerably from its benchmark. While the Fund tends to be fully invested in shares, it may hold some cash or cash equivalent securities.

### What are the Risks of Investing?

The risk indicator for the Devon Australian Fund is below:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down. 

## What fees are investors charged?3

Investors in the Australian Fund are charged Fund charges. In the year to 31 March 2018 these were:

Manager's basic fee:	1.00%
Other management and administration charges	: 0.25%
Performance fees (if applicable):	0.20%

## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the Devon Australian Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$1374 (that is 13.74% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$1303 for the year.
