### What is the purpose of this update?

The Global Themes Fund is actively managed, which means the holdings and investment returns may differ considerably from its benchmark.



#### Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the Global Themes Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of -\$111 (that is -1.11% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of -\$209 for the year.
