What is the purpose of this update?

This document tells you how the Devon Dividend Yield Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Devon Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Dividend Yield Fund is a select portfolio of New Zealand and Australian listed equity securities chosen for their attractive dividend yields, with some growth prospects to maintain the dividend yield and capital value in real terms. The Dividend Yield Fund is actively managed, which means the holdings and investment returns may differ considerably from its bench-mark.

What are the risks of investing?

Lower risk



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the Devon Dividend Yield Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of -\$1,511 (that is -15.11% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of -\$1,609 for the year.
