## What is the purpose of this update?

This document tells you how the Devon Trans-Tasman Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ## Description of this fund

The Trans-Tasman Fund is a select portfolio of well researched companies which are primarily New Zealand and Australian listed companies. The Trans-Tasman Fund is actively managed, which means the holdings and returns may differ considerably from its benchmark. While the Trans-Tasman Fund tends to be fully invested in shares, when there are few compelling investment opportunities the Fund may hold some cash or cash equivalent securities.



### Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the Devon Trans-Tasman Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$995 (that is 9.95% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$916 for the year.
