### What is the purpose of this update?

This document tells you how the Devon Global Sustainability Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. ### Description of this fund

The Fund aims to deliver long-term total returns in excess of the index by investing in the equities of companies globally, that generate high return on capital relative to their peers, and whose management teams and boards display exemplary stewardship to sustain those returns over time.

The Fund obtains this exposure through investment in the Wellington Global Stewards Fund managed by Wellington Management.



## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the Devon Global Sustainability Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$2,277 (that is 22.77% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$2,148 for the year.

As at 31 March 2024, 99.05% of the Fund's underlying exposure is invested in international equities. Of this exposure, 47.14% is hedged to NZ dollars.
