What is the purpose of this update?

This document tells you how the Artesian Green and Sustainable Bond Fund (NZD) has performed and what fees were charged. The document will help you to compare the fund with other funds. Description of this fund

The strategy for the Fund is to invest in a diversified portfolio of Australian and international Green, Social and Sustainable Bonds that have been screened in accordance with Artesian's screening processes. The Fund obtains this exposure through investment in the Artesian Green and Sustainable Bond Fund (AUD) managed by Artesian Corporate Bond Pty Ltd.



Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investments over the long term.

Chris had \$10,000 in the Artesian Green and Sustainable Bond Fund (NZD) at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$707 (that is 7.07% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$487 for the year.

What does the fund invest in?

As at 30 June 2025, 99.41% of the Fund's underlying exposure is invested in International fixed interest. Of this exposure, 99.47% is hedged to NZ dollars.
