What is the purpose of this update?

This document tells you how the Devon Sustainability Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Devon Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund invests in a select portfolio of well researched New Zealand and Australian listed companies that exhibit sustainable characteristics and those which demonstrate credible strategies to improve their outcomes with respect to ESG factors. The Sustainability Fund is actively managed, which means the holdings and returns may differ considerably from its benchmark.

What are the risks of investing?¹

Risk indicator for the Devon Sustainability Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

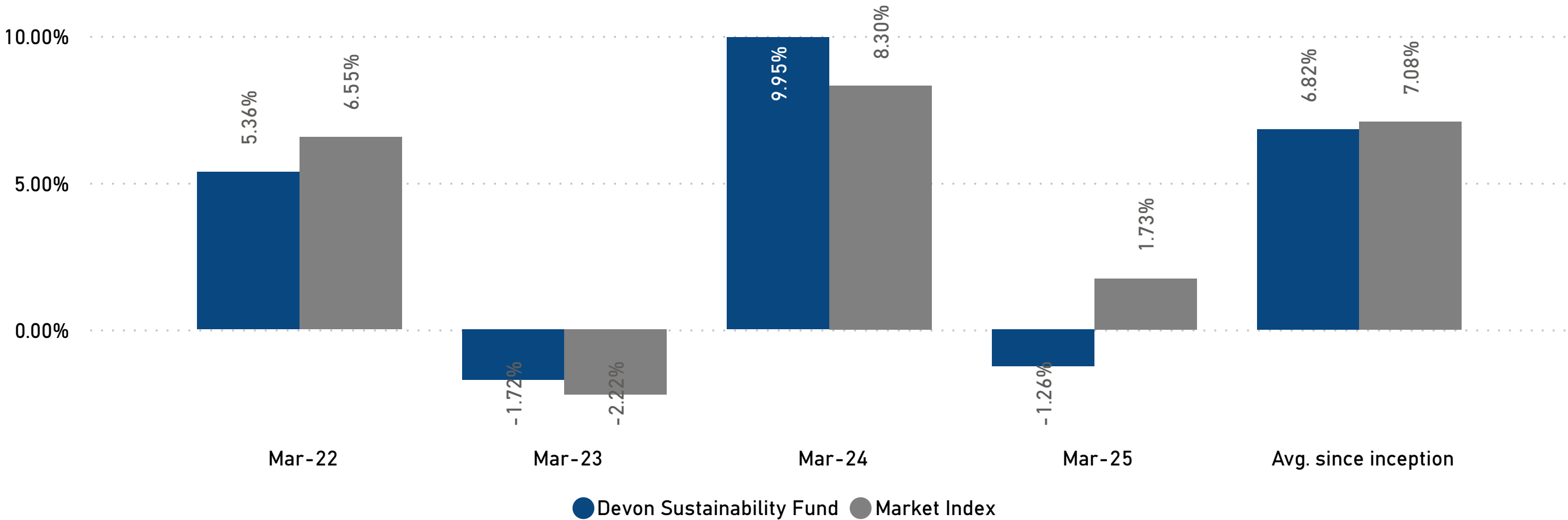

Example of how this applies to an investor

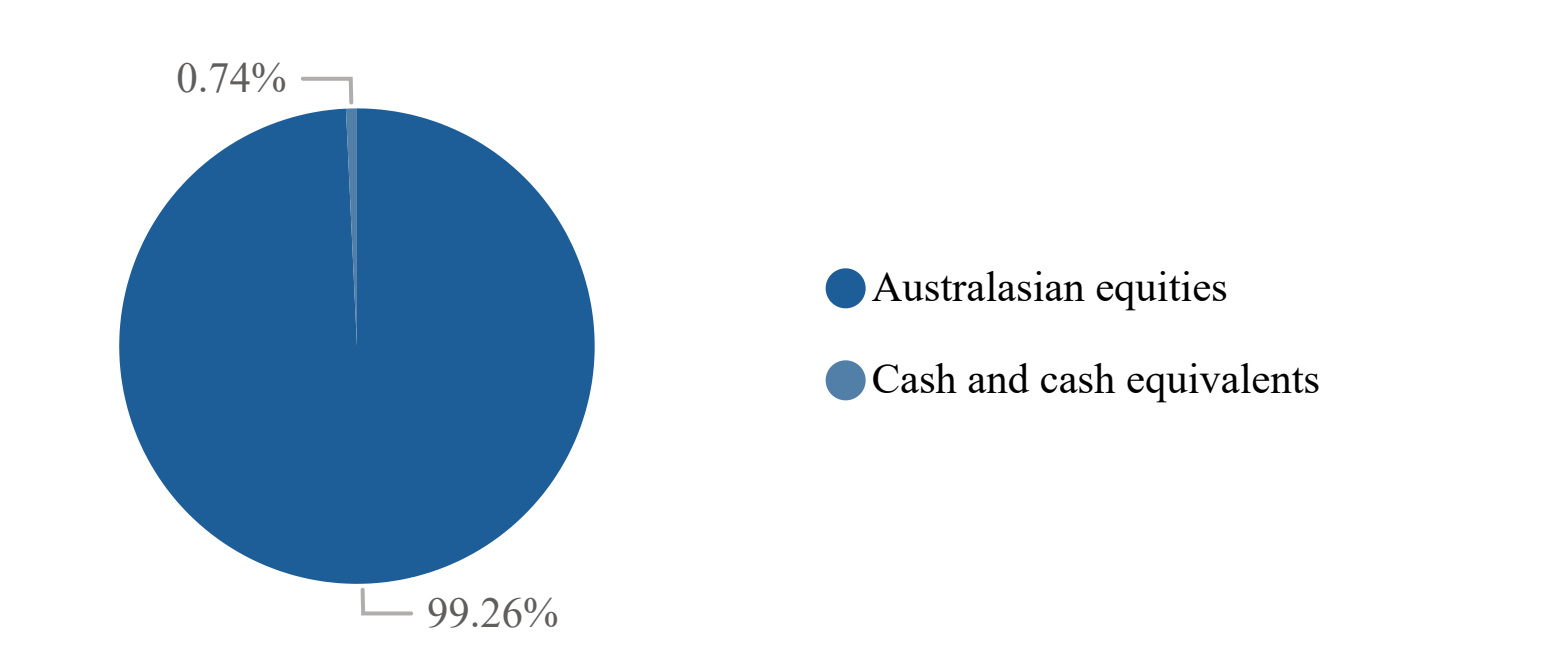
Small differences in fees and charges can have a big impact on your investments over the long term.

Chris had \$10,000 in the Devon Sustainability Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$972 (that is 9.72% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$897 for the year.

The Fund’s currency exposure is actively managed. 97.76% of the overseas currency is currently hedged to NZD.

Notes

1.Because the Fund has not been operational for the required five years we have determined the risk indicator using a combination of index and actual returns. Therefore, it may provide a less reliable indicator of potential future volatility. For the five-year period ending 31 March 2025, market index returns have been used to 31 August 2020 with actual fund returns used for the balance of the period.
