## What is the purpose of this update?



## Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investments over the long term.

Chris had \$10,000 in the Devon Australian Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$1,230 (that is 12.30% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$1,157 for the year.
