What is the purpose of this update?

This document tells you how the Devon Dividend Yield Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Devon Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

The Fund invests in a select portfolio of New Zealand and Australian listed equity securities chosen for their attractive dividend yields, with some growth prospects to maintain the dividend yield and capital value in real terms.

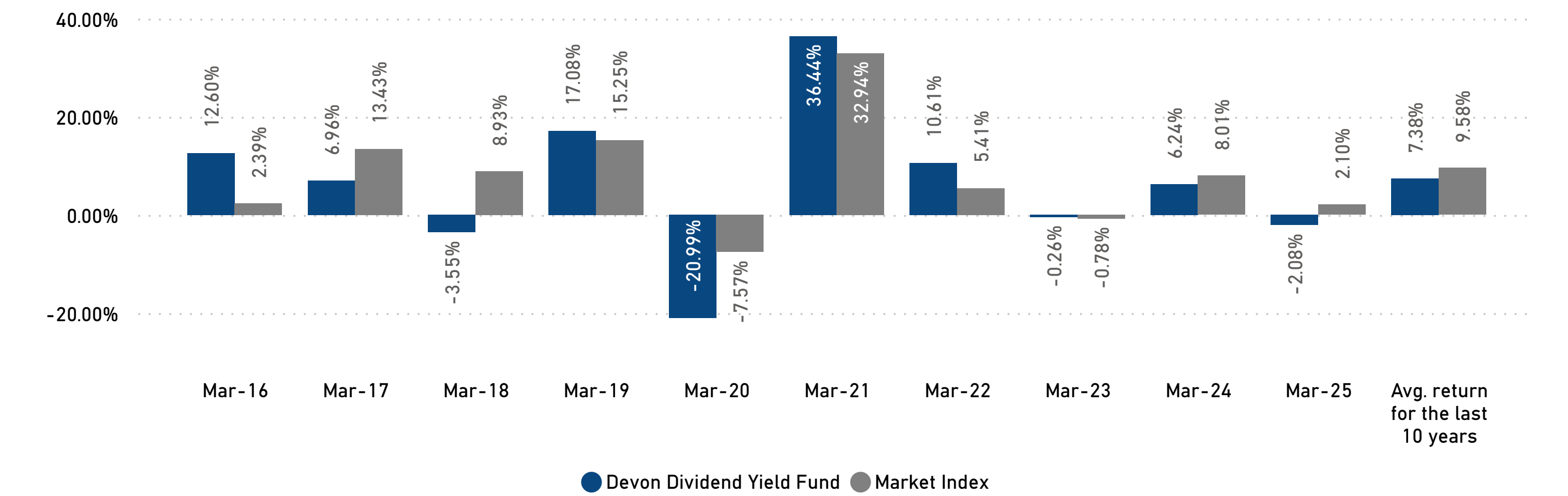

Example of how this applies to an investor

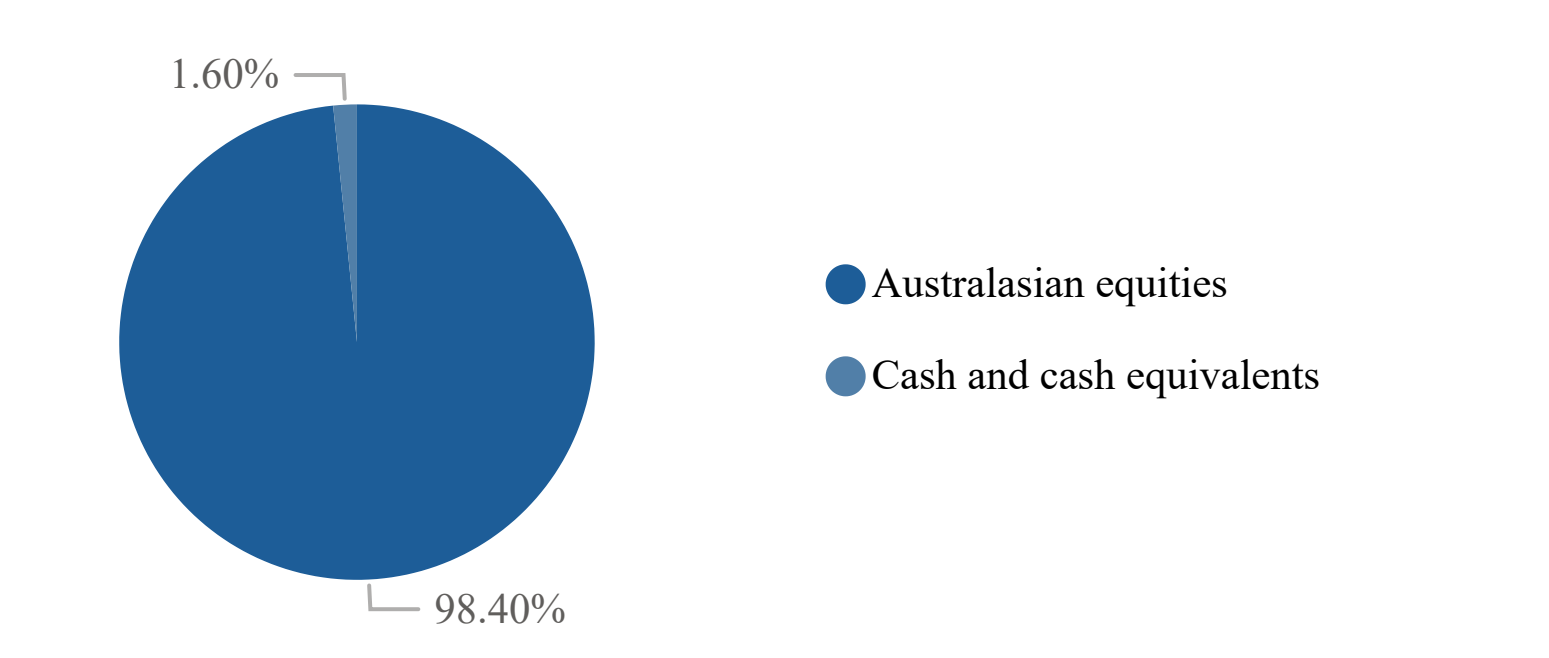
Small differences in fees and charges can have a big impact on your investments over the long term.

Chris had \$10,000 in the Devon Dividend Yield Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$1,796 (that is 17.96% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$1,670 for the year.

The Fund’s currency exposure is actively managed. 97.76% of the overseas currency is currently hedged to NZD.
