What is the purpose of this update?

This document tells you how the Devon Alpha Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Devon Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

A concentrated portfolio of approximately 10-15 select companies listed on the New Zealand and Australian share markets. The Alpha Fund does not follow an equity index and is actively managed. When appropriate investment opportunities cannot be identified, the Alpha Fund may hold cash or cash equivalent securities. The Alpha Fund aims to generate capital growth over the long term.

What are the risks of investing?

Risk indicator for the Devon Alpha Fund



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

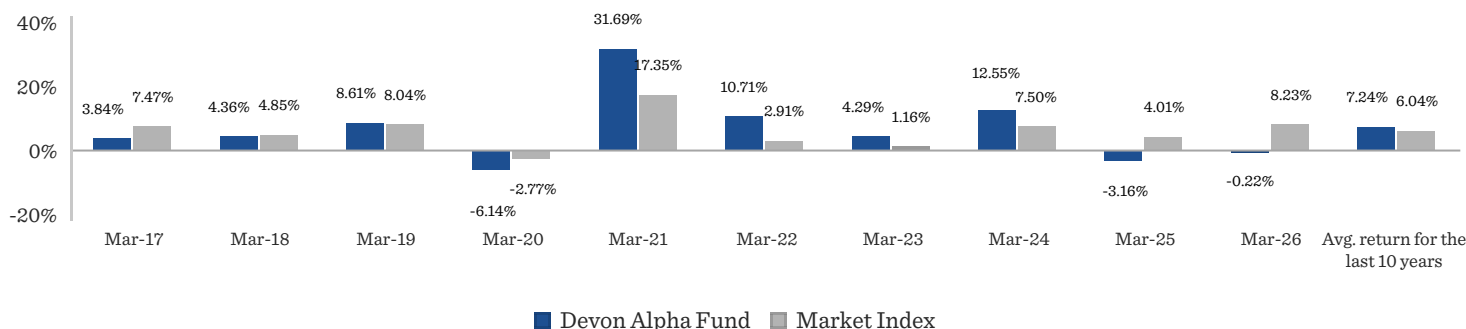

How has the fund performed?

Investors in the Devon Alpha Fund are charged fund charges. In the year to 31 March 2026 these were:

Example of how this applies to an investor

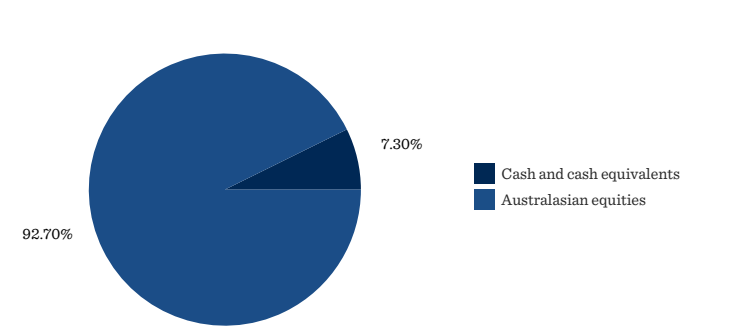
Small differences in fees and charges can have a big impact on your investments over the long term.

Chris had \$10,000 in the Devon Alpha Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$545 (that is 5.45% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$457 for the year.

What does the fund invest in?

The chart (below) shows the types of assets that the Devon Alpha Fund invests in.

The Fund’s currency exposure is actively managed. The portfolio is currently 99.91% hedged against its AUD exposure.
