## DEVON GLOBAL SUSTAINABILITY FUND

### What is the purpose of this update?

This document tells you how the Devon Global Sustainability Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. Devon Funds Management Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

The Fund aims to deliver long-term total returns in excess of the index by investing in the equities of companies globally, that generate high return on capital relative to their peers, and whose management teams and boards display exemplary stewardship to sustain those returns over time.

The Fund obtains this exposure through investment in the Wellington Global Stewards Fund managed by Wellington Management.

### What are the risks of investing?<sup>1</sup>

Risk indicator for the Devon Global Sustainability Fund:



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

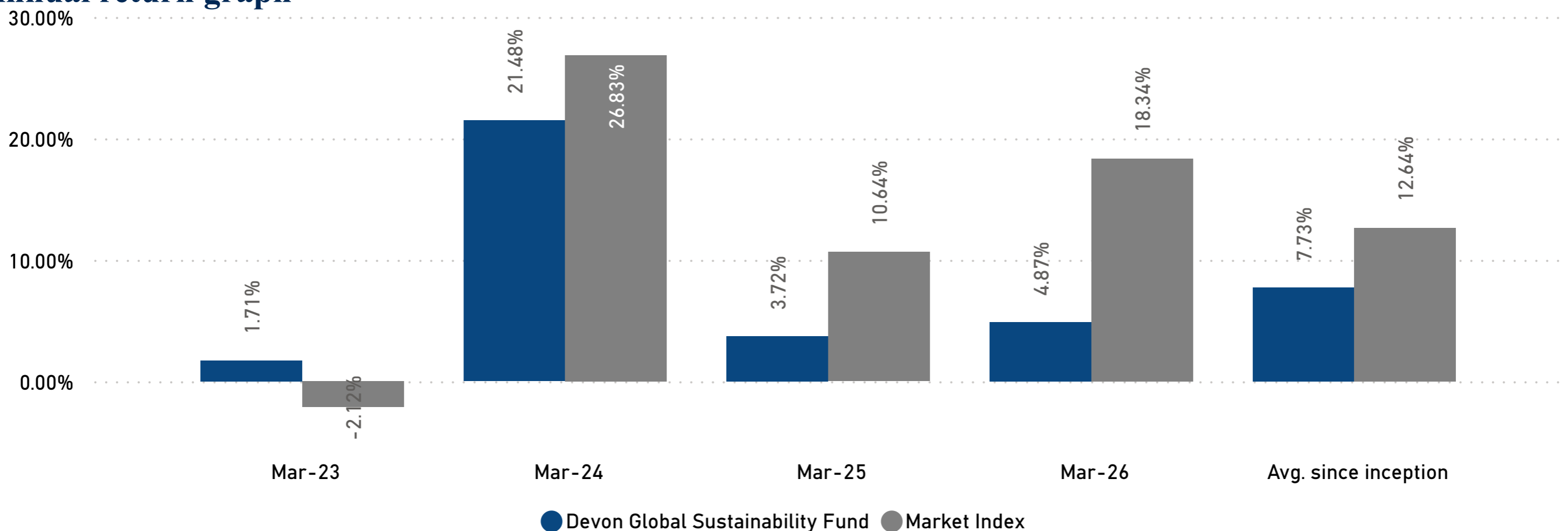

### Annual return graph

## Example of how this applies to an investor

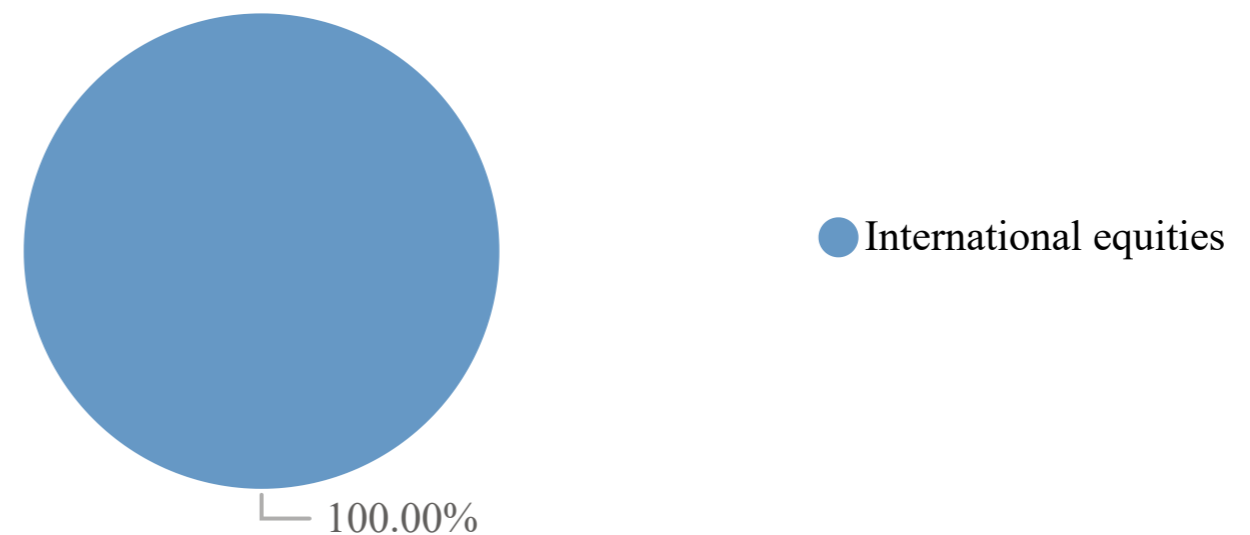
Small differences in fees and charges can have a big impact on your investments over the long term.

Chris had \$10,000 in the Devon Global Sustainability Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$598 (that is 5.98% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$487 for the year.

## What does the fund invest in?

The chart (below) shows the types of assets that the Devon Global Sustainability Fund invests in.

As at 31 March 2026, 100.00% of the Fund's underlying exposure is invested in International equities. Of this exposure, 49.97% is hedged to NZ dollars.

## Notes

1. Because the Fund has not been operational for the required five years we have determined the risk indicator using a combination of index and actual returns. Therefore, it may provide a less reliable indicator of potential future volatility. For the five-year period ending 31 March 2026, market index returns have been used to 27 March 2022 with actual fund returns used for the balance of the period.
