Description of this Fund


The Alpha Fund is a concentrated portfolio of approximately 10-15 select companies on the New Zealand and Australian share markets. The Alpha Fund does not follow an equity index and is actively managed. When appropriate investment opportunities cannot be identified, the Alpha Fund may hold cash or cash equivalent securities. The Alpha Fund aims to generate capital growth over the long term.

What are the Risks of Investing?

The risk indicator for the Devon Alpha Fund is below:


Small differences in fees and charges can have a big impact on your investment over the long term.

Chris had \$10,000 in the Devon Alpha Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$1531 (that is 15.31% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$1510 for the year.
