Devon Funds Management Limited has prepared this document in accordance with the Financial Markets Conduct Act 2013 (FMC Act). You can also seek advice from a financial advice provider to help you to make an investment decision.

Key information summary.

What is this?

This is a managed investment scheme. Your money will be pooled with other investors' money and invested in various investments. Devon Funds Management Limited (**Devon, we, us, our**) will invest your money and charge you a fee for our services. The returns you receive are dependent on the investment decisions of Devon and the performance of the investments. The value of those investments may go up or down. The types of investments and the fees you will be charged are described in this Product Disclosure Statement (**PDS**).

What will your money be invested in?

There are 8 separate funds (**Funds**) offered under this PDS. These investment options are summarised on the following page. More information about the investment target and strategy for each investment option is provided in the "Description of your investment option(s)" on page 6.

Who manages the Devon Investment Funds?

The manager of the Funds is Devon Funds Management Limited. See "Who is involved?" on page 13 for more information about us.

What are the returns?

The return on your investment comes from:

- any increase or decrease in the Fund's unit price; and
- any distributions made to you from the Fund.

The Devon Alpha Fund, Devon Australian Fund, Devon Sustainability Fund and Devon Trans-Tasman Fund intend to pay distributions semi-annually. The Devon Diversified Income Fund, Devon Dividend Yield Fund and the Devon Global Impact Bond Fund intend to pay distributions quarterly. The Devon Global Sustainability Fund does not distribute income, and as such any accrued income for the Fund is reflected in the Fund's unit price. All distributions are at our discretion. See "How does this investment work?" on page 4 for more information.

How can you get your money out?

You may at any time request the redemption of some or all of your investment. Minimum redemption amounts may apply and you will need to complete a redemption request in the prescribed format which is available from Devon on request. Subject to relevant law, we may defer or suspend redemptions in some circumstances. See "How does this investment work?" on page 4 for more information on how to get your money out.

Your investment in the Funds can be sold in accordance with relevant law but there is no established market for trading these financial products. This means that you may not be able to find a buyer for your investment.

How will your investment be taxed?

Each Fund is a Portfolio Investment Entity (**PIE**). The amount of tax you pay in respect of a PIE is based on your Prescribed Investor Rate (**PIR**). To determine your PIR, go to the IRD website www.ird.govt.nz/toii/pir/.

2 How does this investment work?

Devon is an investment management business specialising in building investment solutions for our clients. Our highly qualified and experienced team is committed to helping you achieve your investment objectives. We believe our advantage lies in our people – a dedicated team of investment professionals with many years’ experience in managing portfolios, both within Australasia and further afield. We’ve worked hard to assemble the right talent with the necessary skills and experience to manage your Funds.”

Devon Funds Management is an investment management company based in Auckland. Founded in 2010, we offer a range of funds to New Zealand investors to meet a variety of investment objectives. We manage money on behalf of a diverse range of leading New Zealand clients, including large superannuation schemes, Community Trusts, charities, KiwiSaver schemes, Iwi, corporate pension schemes and individual investors.

Investing in managed funds can help you achieve your savings goals and create greater wealth for your future. We believe some of the potential benefits of investing in our Funds are:

- **Professional Management:** Employing the expertise and resources of a professional manager may be beneficial if you do not have the time or skill to manage your own investments.
- **Diversification:** By pooling together large amounts of money, we are able to invest in a portfolio of securities which allows for diversification with the aim of reducing the risk of your investment. It also provides access to markets and securities that might otherwise be out of reach.
- **Administrative Simplicity:** Our Funds are Portfolio Investment Entities (PIEs). PIEs offer significant advantages from an administrative perspective. We take care of the paperwork involved in buying and selling securities, managing your dividends, interest, corporate actions, reporting and record keeping.
- **Tax Advantages:** Our Funds are all PIEs for tax purposes, meaning that if you are a New Zealand resident unit holder and have supplied us with the correct PIR, tax is usually paid on your behalf at a rate approximating your marginal tax rate and there is no further tax to pay. PIE tax is capped at 28% which can be a benefit for 33% tax rate investors.
- **Responsible Investing:** We believe that by considering Environmental, Social and Governance (ESG) factors across the companies that we own and the sectors that we invest into, we can through time, enhance our ability to meet long-term performance objectives. Incorporating ESG within our process provides us with a greater level of risk analysis and enhances portfolio risk management. We believe that our risk-adjusted returns will be enhanced

through the ownership of companies that execute on their ESG strategies at a high level and also in those companies which demonstrate a commitment to improving their performance with respect to ESG. We are a signatory to the United Nations supported Principles for Responsible Investment (PRI). The PRI provides global principles and a framework to help us integrate the consideration of ESG issues into our investment decision-making and portfolio construction framework. As part of this process we report annually to the PRI on our adherence to these policies. We are also a member of the Responsible Investment Association of Australasia (RIAA). As a member of RIAA, we commit to promoting, advocating for, and supporting approaches to responsible investment that align capital with achieving a healthy and sustainable society, environment and economy. The Devon Sustainability Fund is certified by RIAA. RIAA certification signifies that the Devon Sustainability Fund has implemented an investment style and process that systematically takes into account environmental, social, governance or ethical considerations, and this investment process reliability has been verified by an external party. Certification also signifies that the Devon Sustainability Fund adheres to the strict operational and disclosure practices required by RIAA's Certification Program. This PDS is an offer of units in the Devon Investment Funds. Each Fund is constituted within a Managed Investment Scheme that is governed by the **Devon Trust Deed** (dated 30 September 2016).

The money you invest buys units in the Fund(s) you've chosen. The price of each unit you receive depends on the value of the Fund at the time you invest. We calculate the unit price by dividing the Net Asset Value of the Fund by the number of units the Fund has on issue. We also have the discretion to include trading costs in determining the unit price received. The unit price is calculated daily and published on our website. Daily unit prices for each Fund will change as the market value of those Funds' assets change. The return on your investment is reflected in any increase or decrease in the unit price and any distributions from the Fund(s).

The number of units you have (your **unitholding**), when multiplied by the unit price, gives you the total value of your investment in the Fund (although the impact of tax can result in a change in the number of units you hold, up or down, as the unit price is calculated before tax). No assets of a Fund will be available to be applied to meet the liabilities of any other Fund managed by us.

Distributions

The Devon Alpha Fund, Devon Australian Fund, Devon Sustainability Fund and Devon Trans-Tasman Fund intend to pay distributions semi-annually. The Devon Diversified Income Fund, Devon Dividend Yield Fund and the Devon Global Impact Bond Fund intend to pay distributions quarterly. The Devon Global Sustainability Fund does not distribute income, and as such any accrued income for the Fund is reflected in the Fund's unit price. All distributions are at our discretion. You can elect to have distributions re-invested in the Fund or direct credited to your bank account. Please note, we do not pay to third party bank accounts.

Making investments

You can make lump sum or regular investments into the Funds. Investments can be made by completing the application form for the relevant Fund(s) at the back of this PDS. A NZ\$10,000 minimum applies for the initial contribution and NZ\$100 minimum per quarter for subsequent regular payments. For information on how to invest in the Fund(s), see "How to apply" on page 14.

Withdrawing your investments

If you wish to make a redemption you must complete a redemption request in the prescribed format which is available from Devon on request. Once submitted, your redemption request is not able to be withdrawn. We have the ability, in certain circumstances to suspend or defer redemptions. In the event that this should ever occur, you can still submit a redemption request and these will be processed, in the order in which they are received, once the suspension or deferral has been lifted.

You may withdraw amounts of \$2,000 or more. If your withdrawal would result in your investment falling below \$2,000, we may request the Supervisor to withdraw the balance of your holding and repay the proceeds back to you.

Withdrawal requests will be processed each business day in Auckland. The withdrawal value of the units will be paid to you, after adjustment for any tax payable (if applicable), within 30 business days from the date your withdrawal request is received. No person guarantees or promises the repayment of, or returns on, your investment in the Funds.

How to switch between Funds

You can also switch between Funds as often as you like. Completed switch requests will be made on the next available unit price. A switch will be treated as a redemption from one Fund and an application into another Fund. A switching form is available from Devon on request.

If this monitoring programme was to identify a possible exception (for example, a company with more than 10% of business revenue derived from the manufacture of alcohol), the holding will be disposed of within 30 days in normal market conditions. In the event of a breach being identified, Devon will communicate with clients on both the nature of the breach and the steps taken to address the breach.

What are the risks of investing?

Understanding the risk indicator

Managed funds in New Zealand must have a standard risk indicator. The risk indicator is designed to help investors understand the uncertainties both for loss and growth that may affect their investment. You can compare Funds using the risk indicator.

An example of our risk indicator is below.



The risk indicator for each of the Funds can be found on page 2 of this PDS.

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the Fund's assets goes up and down (volatility). A higher risk generally means higher potential returns over time, but more ups and downs along the way.

To help you clarify your own attitude to risk, we suggest you seek financial advice or work out your risk profile at www.sorted.org.nz/calculators/investment-planner.

Please note that even the lowest category does not mean a risk-free investment, and there are other risks (described under the heading "Other Specific Risks") that are not captured by this rating. This risk indicator is not a guarantee of a Fund's future performance. The risk indicator is based on the returns data for the five years to 31 December 2025 where available. While risk indicators are usually relatively stable, they do shift from time to time. You can see the most recent risk indicator in the latest quarterly Fund Update for these Funds.

A combination of actual Fund returns and market index returns, as outlined on page 2, has been used to determine the risk indicator for the Devon Global Impact Bond Fund, Devon Global Sustainability Fund and Devon Sustainability Fund as these Funds have not been operational for the required 5 years.

General investment risks

Some of the things that may cause a Fund's value to move up and down, which affect the risk indicator, are:

Market risk: Risk of losses based on the overall performance of financial markets.

Security specific risk: Risks that are specific to a particular security.

Currency & hedging risk: Risk of losses from fluctuating foreign exchange rates.

Interest rate risk: Risk that a security's value will change due to a change in interest rates.

Investment objective risk: Risk that the investment objectives of a Fund will not be met.

Concentration risk: Risk arising from a Fund's assets being concentrated in a particular security, group of securities, geographical area, industry or other grouping.

Operational risks: Risk of an error in procedures or systems which impacts the pricing of units in a Fund.

Emerging markets: Emerging markets may be

Other specific risks

ESG: The Devon Global Impact Bond Fund, Devon Global Sustainability Fund and Devon Sustainability Fund use ESG exclusions (negative screens) to assist in making investment decisions. The Devon Alpha Fund, Devon Australian Fund, Devon Diversified Income Fund, Devon Dividend Yield Fund and Devon Trans-Tasman Fund's primary objective is not related to ESG factors. However, the consideration of ESG factors is an essential part of Devon's investment process. ESG screens are included in the pre-investment phase of an investment to ensure investment companies align with our stated objectives. We constantly monitor any changes with regard to ESG factors as part of our ongoing decisions to retain or divest investments. The outcome of these screens may reduce the returns you receive.

In the case of the Devon Global Impact Bond Fund and Devon Global Sustainability Fund, there is also a risk that the outcome of the screening performed, and investment decisions made by the underlying fund manager (Wellington Management), may not align with your preferences. 5 What are the fees?

You will be charged fees for investing in the Funds. Fees are deducted from your investment and will reduce your returns. If we invest in other funds, those funds may also charge fees. The fees you pay will be charged in two ways:

- regular charges – for example annual fund charges and performance fees. Small differences in these fees can have a big impact on your investment over the long term; and
- one-off fees – for example abnormal legal or regulatory fees.

Some of the fees charged to the Funds in the table above are subject to goods and services tax (GST), while others are GST-exempt. To clarify, investment management services provided to the Funds are exempt from GST, so GST is not charged on the management fee, or any performance-based fee paid to us. All other services provided to the Funds are subject to GST at the standard rate of 15%. The total annual fund charges are an estimate of each Funds Net Asset Value (NAV) and shall not exceed the amount shown above for each Fund. All fees are accrued daily, paid monthly in arrears to us and are reflected in the unit price.

The charges outlined above cover:

Management fee: all investment management services, including amounts due to external fund managers.

Administration charges: all other expenses including supervisor, custodian, administration, registry, unit pricing, fund accounting, legal, audit and regulatory compliance. Additionally, the Manager and the Supervisor are entitled to be reimbursed out of each Fund for all other expenses properly and reasonably incurred by the Supervisor or the Manager in connection with carrying out their respective duties under the Trust Deed.

Performance-based fees: These are estimates calculated on the basis of combined Fund returns since inception and market performance from 30 June 1992 to 31 December 2025 (33.5 years) as described in Devon's Other Material Information document located at www.business.govt.nz/ disclose. We have not made any estimate for outperformance of the market by the Funds.

Given this, and the use of long term averages, it is to be expected that actual performance fees may be more (or less) than shown in the table in any given year. In particular, investors should be aware that the Devon Alpha Fund does not track a market index. Please see the details of how the

performance fees are calculated below. Actual performance-based fees for the most recent scheme year will be available in the latest quarterly Fund Update.

If Devon invests in other Funds, those Funds may also charge fees. At the date of this PDS, the Devon Diversified Income Fund invests into the Devon Dividend Yield Fund, the Devon Global Impact Bond Fund invests into the Wellington Global Impact Bond Fund, and the Devon Global Sustainability Fund invests into the Wellington Global Stewards Fund. All fees from these investments are fully refunded.

There are currently no individual action fees, no establishment, termination, withdrawal or switching fees charged to the Fund. We can introduce these fees in the future in accordance with the Trust Deed and applicable law.

Brokerage and other transaction costs are paid directly by the fund. Under the terms of Funds governing document, other expenses such as one-off costs and taxes may also be charged to the Fund.

Performance-based fees

Some of our Funds have performance-based fees if they earn above the Fund's hurdle rate of return, subject to a high water mark, as detailed below. The use of a high water mark ensures that you do not pay for the same performance twice. The term high water mark means the highest value that a Fund has achieved on previous performance fee calculation dates. Performance-based fees are only payable if a Fund's performance exceeds the high water mark. A high water mark ensures that if a manager loses money over a period, they must achieve investment returns above the high water mark before receiving a performance-based fee. The high water mark can be reset every three years at our discretion in conjunction with the Supervisor.

Mel invests \$10,000 in the Devon Trans-Tasman Fund. She is not charged an establishment fee or contribution fee. This brings the starting value of her investment to \$10,000.

She is charged management and administration fees, which work out to about \$131 (1.31% of \$10,000) over the year. These fees might be more or less if her account balance has increased or decreased over the year.

What taxes will you pay?

Each Devon Fund is a portfolio investment entity (PIE). The amount of tax you pay is based on your prescribed investor rate (PIR). To determine your PIR, go to www.ird.govt.nz/pir. If you are unsure of your PIR, we recommend you seek professional advice or contact the Inland Revenue Department.

It is your responsibility to tell Devon your PIR when you invest or if your PIR changes. If you do not tell Devon, a default rate may be applied. If the rate applied to your PIE income is lower than your correct PIR, you will be required to pay any tax shortfall as part of the income tax year-end process. If the rate applied to your PIE income is higher than your PIR, any tax over-withheld will be used to reduce any income tax liability you may have for the tax year and any remaining amount will be refunded to you.

We may change your PIR if Inland Revenue tell us to.

Conditions of this authority to accept Direct Debits
