


Small differences in fees and charges can have a big impact on your investments over the long term.

Chris had \$10,000 in the Devon Trans-Tasman Fund at the start of the year and did not make any further contributions. At the end of the year, Chris received a return after fund charges were deducted of \$106 (that is 1.06% of his initial \$10,000). Chris does not pay any other charges. This gives Chris a total return after tax of \$41 for the year.
